Background: Project Court REACH

- Project Court REACH: **R**igorous and **E**vidence-based **A**pproaches for **C**ourt-based **H**ealth Promotion
- Project Court REACH is an implementation science research project
 - Goal: To enhance opioid court operations in New York and improve participants' access to recovery supports and treatment.
- Project REACH is funded by the National Institute on Drug Abuse (NIDA; U01 DA050071)

Opioid Courts in New York: A Brief History

Opioid Use Disorder (OUD) in the Justice System Population

- Opioid-related arrests have spiked nationally
- Opioid overdose is the leading cause of death post-release

Buffalo's Opioid Intervention Court

- Developed to rapidly treat those with OUD to prevent overdose death
- Immediate linkage to evidence-based treatment and intensive supervision

NYS Opioid Court Expansion

- The opioid court model is now being expanded across NYS
- A panel of national experts developed the essential elements for opioid courts, incorporating evidence-based practices and Buffalo's model

1. Broad legal eligibility

2. Immediate screen for overdose risk

3. Informed consent after consultation with defense counsel

4. Suspension of prosecution or expedited plea during treatment

5. Rapid clinical assessment and treatment engagement

The 10 Essential Elements of Opioid Intervention Courts



6. Recovery support services

7. Frequent judicial supervision and compliance monitoring

8. Intensive case management

9. Program completion and continuing care

10. Performance evaluation and program improvement



There is limited guidance on how to develop and implement opioid courts, especially given the **variability of county resources and characteristics**

The Project Court REACH research and technical assistance team is working with ten New York courts to put the *Ten Essential Elements* into **realistic practice**

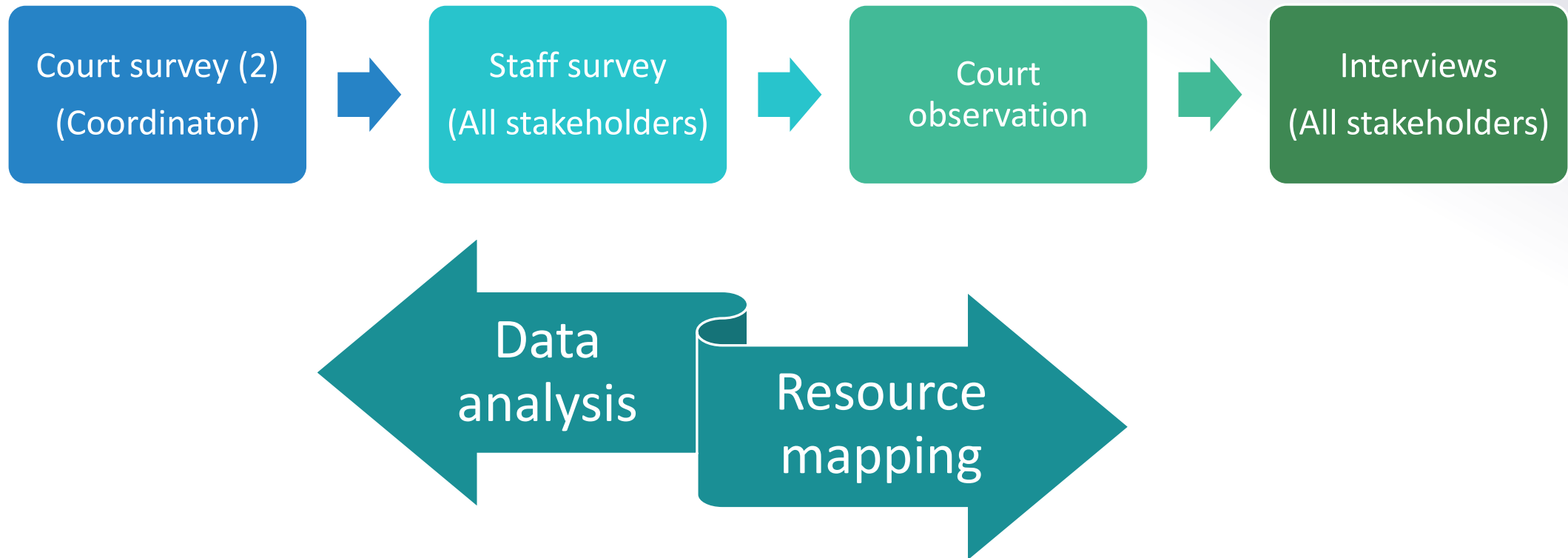

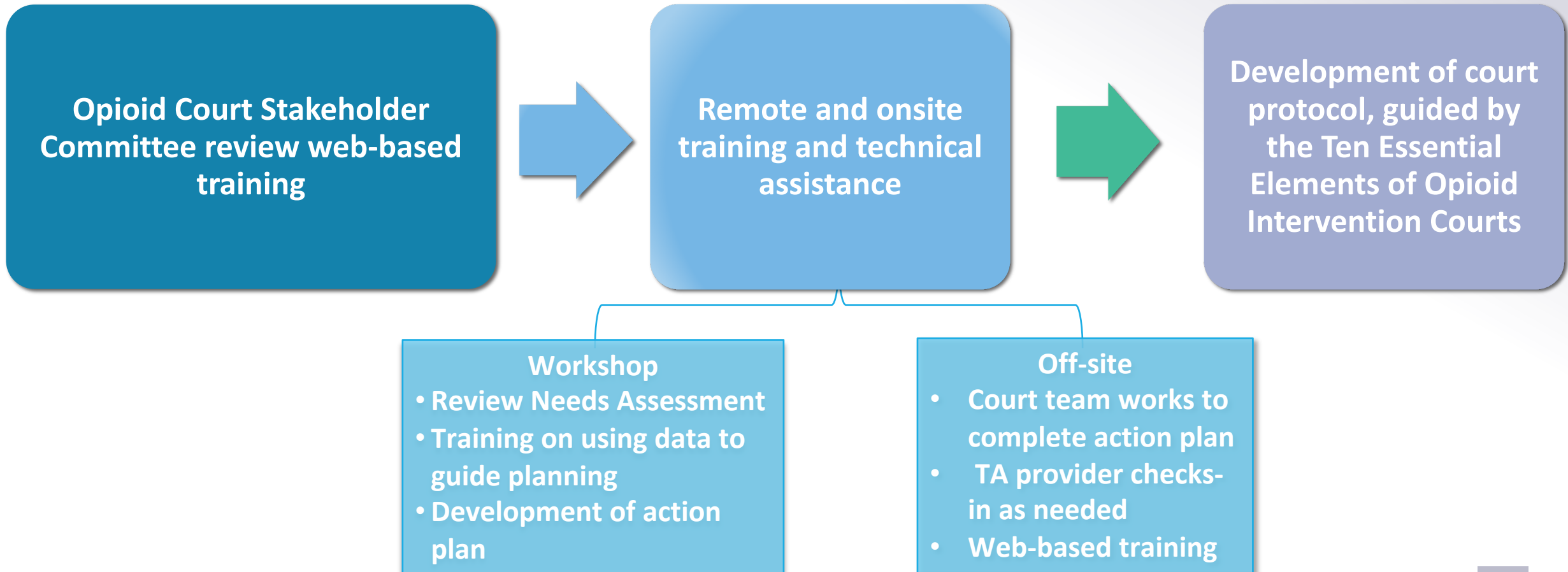

Phase 1: Needs Assessment



Phase 2: Preparation

Development and Execution of Strategic Implementation Guide to Launch Opioid Court (~6 months)



Phase 3 & 4: Roll Out of Opioid Court

With Guided TA to Improve Ongoing Performance

Implementation Phase: Active review (12 months)



Sustainment Phase: Routine review (6-18 months)

Feedback mechanisms during Phase 3 & 4:

- Bi-monthly check-in call with Court Team leader during Phase 3
- Opioid Court team focus group at the end of Phase 4

So What's the Research Part?

- With your **consent** we will be collecting data as we go.
 - **Online survey**: thoughts on opioid court, MOUD, readiness to get the court operational/improve functioning, and experiences working with treatment/court systems. (Phase 1 and end of Phase 3)
 - **Pre-post quizzes** that are associated with the web-based training modules (provide CLEs)
 - **Monthly check-in phone call** (10 mins) to describe progress, staff turn over, etc. (Court liaison only) throughout Phase 3.
 - **Focus group** with the stakeholder group at the end of Phase 4.
- These research activities are **all voluntary** and you can chose to participate in all, none, or some.

How Are My Data Protected?

- We protected your data in a number of ways:
 - Consent form is not signed -- no link to you.
 - Online surveys are anonymous; data secured on encrypted server
 - Results are ONLY presented in aggregate – no individual will EVER be identified in publications or presentations
 - Certificate of Confidentiality from NIH – prevents research data from being subpoenaed.
 - Focus groups are recorded but no names are included in transcripts nor names/county identifiers included on the digital audio files
